

ORDINANCE No. 186199

* Authorize a contract with Palouse-Clearwater Environmental Institute to sponsor a Confluence AmeriCorps member in Parks & Recreation Urban Forestry for a term from September 4, 2013 to July 25, 2014 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. On December 10, 2003, Council adopted the Urban Forestry Management Plan, which describes actions for forest health, including preserving, restoring and expanding the urban forest; promoting stewardship of the urban forest; and providing equitable access to the benefits of the urban forest.
2. As an AmeriCorps service program, the Confluence Environmental Center (CEC) provides service members to address the health of the natural environment and promote environmental education in underserved communities. Portland Parks & Recreation (PP&R) has sponsored AmeriCorps members through a similar program, the Northwest Service Academy (NWSA) since 2010. The NWSA closed its operations in Oregon in the fall of 2011. In its place, CEC will provide a comparable service to PP&R.
3. Pursuant to the agreement, attached as Exhibit A, CEC will provide Portland Parks & Recreation with an AmeriCorps service member who will serve as a tree plan outreach coordinator.
4. The established cost is \$13,000 for Fiscal Year 2013/2014. These funds are due by August 30, 2013. No additional funding will be requested.

NOW, THEREFORE, the Council directs:

- a. The Director of PP&R is hereby authorized to execute an agreement with CEC, in substantially the same form as Exhibit A attached herein and as approved as to form by the City Attorney, for the purpose described in Section 1.
- b. The Director of Portland Parks & Recreation and the Auditor are authorized to provide payment in the amount of \$13,000, chargeable to the applicable budgets when demand is presented and approved by the appropriate authorities.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the commencement of the services to be provided by the AmeriCorps member; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
