Section 1. The Council finds:

- 1. The property owners and registered voters have initiated a proposal by a consent petition to annex to the City of Portland, the subject territory, described in Exhibit "A" and shown on the map in Exhibit "B" is withdrawn from the Multnomah County Service District #14 (street lights) and Tualatin Valley Fire & Rescue.
- 2. The property owners want to annex to Portland to obtain City sewer service for one existing and one future single family dwelling of the property within the boundaries of the City's Urban Services Boundary.
- 3. Based on the findings and reasons for decision detailed in Exhibit "B," this proposal for annexation sufficiently meets applicable criteria for approval.

NOW, THEREFORE, the Council directs:

- a. The proposed annexation of the property described in Exhibit "A" is approved.
- b. The subject territory, shown on the map in Exhibit "B," is withdrawn from the Multnomah County Service District # 14 (street lights) and Tualatin Valley Fire & Rescue.
- The City Auditor is authorized and directed to file a certified copy of this Ordinance with c. the Boundary Change Office of Metro.

Section 2. The Council declares that an emergency exists in order that there be no delay in extending services, therefore, this Ordinance shall be in force and effect from and after its passage by Council.
