

ORDINANCE No. 186221

* Accept a grant in the amount of \$15,000 and appropriate \$7,500 for FY 2013-14 for the Oregon Department of Transportation, Transportation Safety Division 2013-15 Work Zone Enforcement/Photo Radar Project for sworn personnel overtime (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Transportation (ODOT), Transportation Safety Division (TSD) for the 2013-15 Work Zone Enforcement Program grant on June 13, 2013;
2. The Oregon Department of Transportation has notified the City that it will award a grant for the 2013-15 Work Zone Enforcement/Photo Radar Project to the Police Bureau in the amount of \$15,000;
3. The ODOT project will fund overtime for the Police Bureau Traffic Division to provide high visibility and high contact enforcement efforts while on patrol in identified ODOT work zones;
4. The Oregon Department of Transportation will reimburse the City a maximum of \$15,000 for sworn personnel overtime expenses incurred by the Traffic Division;
5. Local match in the amount of \$2,915 will be provided by funds from bureau program budget appropriations;
6. The grant period is July 1, 2013, through September 30, 2015; and
7. The Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from ODOT for the 2013-15 Work Zone Enforcement/Photo Radar Project in the amount of \$15,000.
- b. The FY 2013-14 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area - PL

Bureau Program Expenses - \$7,500

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by ODOT for the 2013-15 Work Zone Enforcement/Photo Radar Project, 1315WKZN-421 BBB, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.


