

ORDINANCE No. 186248

* Authorize a grant agreement to provide All Hands Raised, formerly the Portland Schools Foundation, \$800,000 for support of the Cradle to Career Partnership (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The City of Portland recognizes that the city's future economic and social well-being are dependent on ensuring a strong educational foundation for all our city's youth; and
2. The City of Portland is concerned about the number of students dropping out of high school, with only 53%-64% of local students graduating on time; and
3. The City recognizes the mission of All Hands Raised to manage the Cradle to Career Partnership which catalyzes the effort needed inside and outside of the classroom to assure all kids in all neighborhoods throughout Portland and Multnomah County achieve their full potential, and further recognizes the need for this crucial work to be sustained.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into a Grant Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$800,000. This amount is to be allocated at \$200,000 for each of the next four fiscal years, starting with FY 2013-14.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2013-14 Adopted Budget.


