WHEREAS, federal regulations require environment reviews and certification for all federally funded projects, prior to allocation and commitment of funds; and

WHEREAS, the Certifying Officer is the individual who has the responsibility of completion and approval of the environmental review; and

WHEREAS, in the past the Director and Compliance Coordinator of the Portland Housing Bureau has been designed to carry out this function; and

WHEREAS, there has been staff changes in the positions of the Director and Compliance Coordinator.

NOW, THEREFORE, BE RESOLVED by the Council of the City of Portland, a Municipal Corporation of the State of Oregon, that the City:

- (a) Certifies the Director and the Compliance Coordinator, or anyone acting as Director or Compliance Coordinator, of the Portland Housing Bureau, as Certifying Officers for federally required environmental reviews certifications.


