ORDINANCE No. 186258

*Authorize a sole source contract with Online Enterprises Inc. dba Online Business Systems, Inc. to implement an enterprise service bus and associated interfaces to the RegJIN Records Management System for a not-to-exceed amount of \$525,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. A contract with Versaterm, Inc. was authorized on June 12, 2013 by the City Council for the main portion of the Portland Police Data System (PPDS) replacement project (the RegJIN project).
- 2. This contract is a separate component of the RegJIN project and will enable the implementation of the high priority data exchange required by the RegJIN system.
- 3. This contract is fully funded by UASI Homeland Security FY2011 Grant (UA11-0037)
- 4. Research identified Online Enterprises Inc. as the only qualified, experienced firm capable of completing the required work within the UASI Grant deadlines.
- 5. A Notice of Intent to execute a Sole Source Contract (project #115821) was posted on the Procurement Services Website on July 22, 2013 for a period of seven days and no objection to the contract was received.

NOW, THEREFORE, the Council directs:

a. The Chief Procurement Officer is hereby authorized to sign a contract with Online Enterprises Inc. (DBA Online Business Systems, Inc.) for a not to exceed amount of \$525,000 for the implementation of an Enterprise Service Bus (ESB) and associated interfaces to the RegJIN RMS project (the Portland Police Data System replacement), provided the contract has been approved as to form by the City Attorney's office.

Section 2. The Council declares that an emergency exists because delay in funding would place the UASI grant funds in jeopardy and create a significant delay in implementing the RegJIN RMS project with the Regional Partner Agencies; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


