### 1) Legislation Title:

\*Authorize contract with Online Enterprises Inc. (DBA Online Business Systems, Inc.) to implement an enterprise service bus (ESB) and associated interfaces to the RegJIN Records Management System for a not to exceed amount of \$525,000.

### 2) Purpose of the Proposed Legislation:

This legislation will authorize the execution of a sole source contract with Online Enterprises, Inc., to develop and install a modernized law enforcement Enterprise Service Bus (ESB) and four (4) Jail Management System, five (5) Computer Aided Dispatch, and fifteen (15) Property System interfaces to the RegJIN RMS. The RegJIN RMS contract with Versaterm Inc. was approved by Council on June 12 and this contract funds a portion of the other side of interfaces to the RegJIN system and assists partner agencies and PPB to fully utilize the new RegJIN system. RegJIN will provide important information to law enforcement officers remotely in their vehicles while on patrol and eliminate redundant data entry and associated transcription errors. Over 5,000 users in 36 separate law enforcement agencies (including the Portland Police Bureau) located in the five-county Portland Metropolitan region will use the RegJIN system and the software developed through this contract. A UASI 2011 Homeland Security Grant will fund the cost of this contract. This contract has been "sole sourced" because the technical requirements are unique and no other qualified, experienced vendors are able provide the required software, source code and associated services within the timeline required by the UASI grant funds.

No. The ongoing maintenance and support will be funded by the Portland Police Bureau and the participating public agencies using the system.

The contract amount is approximately \$525,000, which will be completely funded by a FY2011 UASI Homeland Security grant (UA11-0037). The City will own the resulting source code and software and will be fully trained on maintaining and supporting the software/system once it is accepted by the City. City resources required to support and maintain the system will be funded by the Portland Police Bureau and the participating public agencies using the system.

The RegJIN Project Charter includes a multi-agency Project Advisory Committee and implementation team which fully reviewed and approved proceeding with this contract. No protests or questions were received.

The Project Advisory Committee and implementation team reviewed and approved the contract.

### 7. <u>BACKGROUND/ANALYSIS</u>:

The RegJIN Law Enforcement Records Management System contract with Versaterm, Inc was approved by the City Council on June 12, 2013. This contract is for a separate component of the RegJIN system and funds the development and implementation of a modernized law enforcement enterprise service bus (ESB) and four (4) Jail Management System, five (5) Computer Aided Dispatch, and fifteen (15) Property System interfaces to the RegJIN RMS. The contract with Versaterm that was previously approved by the Council funds the development of the System side of the required interfaces (data exchanges). This contract funds the development of the none-Versaterm sides of the interfaces along with developing a data exchange hub that can be further enhanced and deployed by the City in the future to manage other data exchanges required in the City.

The interfaces developed through this contract will enable regional law enforcement officers and deputies (including members of the Portland Police Bureau) to

- btain near real time information relevant to preventing and solving crimes,
- - ink events that occur in different parts of the region to each other; and
- ٠
- omplete their work more accurately and efficiently.

Linking the five separate Computer Aided Dispatch (CAD) systems being used in the area to the RegJIN system enables officers and deputies to remotely obtain recent activities occurring within their patrol areas and to complete required reports more accurately and efficiently by pre-filling CAD information available about the subject of their reports. Linking the five Jail Management Systems deployed in the area (one per county) enables the real time retrieval of mug shots, the automatic delivery of arrestee information to each jail facility thereby eliminating redundant data entry, and the tracking of verified arrestee identifications. Linking the fifteen standalone property and evidence tracking systems to the RegJIN system eliminates redundant data entry, enables starting chain of evidence tracking in the field, and enables the region wide identification of stolen and recovered items.

identify qualified and sufficiently experienced companies able to provide the required software development effort and associated services. The search resulted in the identification of Online Business Systems as the only firm able to complete the work within the UASI Grants timeline and the requirement for the City to own the ESB software, source code and interfaces after they are developed.

Further research identified that Online Business Systems, Inc. (OBS) is:

- The only qualified vendor that has been authorized by Versaterm, Inc., the RegJIN project system vendor, to develop an interface and ESB to the RegJIN version of Versaterm's Versadex RMS.
- OBS was selected to implement the Portland Dispatch Center Consortium (PDCC) ESB through a competitive procurement process and the ESB and interfaces required for the RegJIN project require similar development and implementation services. OBS has extensive knowledge of the existing PDCC ESB that needs to be interfaced with the RegJIN ESB, which will eventually replace it. The current technology platform on which the PDCC ESB is built (Sonic) is no longer supported.
- OBS' development of the PDCC ESB, and resulting familiarity with the CAD systems and other systems involved in this project, puts OBS in a uniquely strong position to meet the strict time constraints imposed by the UASI grant funds used to fund this portion of the RegJIN project.
- OBS is capable of developing interfaces and an ESB that will comply with Criminal Justice Security Policies.

As a result of these findings, a Notice of Sole Source Procurement (project #115821) was prepared and posted by Procurement Services on its web site. The notice was published for 7 days and no protests or questions were received during the posting period.

Online Enterprises Inc. (DBA Online Business Systems, Inc.) has a current City of Portland business license, is in full compliance with the Equal Benefits Program, and their EEO Certification is current. Online Enterprises, Inc. is located in the City of Portland (at 400 SW 6<sup>th</sup> Avenue, Suite 500, Portland OR 97204) and is not a State of Oregon Certified MWESB contractor.

### 8. **<u>FINANCIAL IMPACT:</u>**
