

**ORDINANCE No. 186261**

Accept donation of Code-Stat 9 and LIFENET software and licenses from Physio Control, Inc. to transmit data from emergency scenes to helath care providers  
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. On January 9, 2013, Council passed Ordinance 185853 accepting a donation of modems from Legacy Health in order to build a data transmission system that allows local hospitals to receive vital data for cardiac patients in real time.
2. In order for the modems to work, they require licenses for Code-Stat 9 and LIFENET software.
3. The vendor of Code-Stat 9 and LIFENET software is Physio-Control, Inc.
4. Physio-Control is giving Portland Fire & Rescue licenses to both Code-Stat 9 and LIFENET, for use in transmitting data from emergency scenes directly to health care providers.
5. Implementation of this system will help ensure a better outcome for most cardiac patients.
6. The Bureau of Technology Services (BTS) is aware of this donation.
7. The software does not require BTS support.
8. The approximate value of the donation is \$5,000.
9. The Fire Chief recommends that the Council accept the donation from Physio-Control, Inc.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation of the Code Stat 9 and LifeNet software and licenses for Portland Fire & Rescue, and thanks Physio-Control, Inc. for its donation.
