

## ORDINANCE No. 186270

Authorize a Letter Agreement with the Oregon Department of Transportation in the amount of \$10,000 to provide traffic control during work to abandon sewer facilities on I-84 at the NE 12<sup>th</sup> St crossing (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. As part of the Bureau of Environmental Services (BES) Oak B Basin Project No. E08387 completed in 2011, the diversion structure located in the left (fast) lane of eastbound I-84 was no longer required. As a result, The diversion facilities need to be properly abandoned due to their age, condition, and high consequence of failure. BES has now proceeded with abandonment of these facilities.
2. BES and the Oregon Department of Transportation (ODOT) developed a coordinated safety plan for the abandonment work. The plan called for ODOT to provide traffic control on I-84 while BES and its contractor performed the work.
3. The estimated cost is \$10,000. Funds are available in the Sewer System Operating Fund, FY2014 Budget, Bureau of Environmental Services, CIP, E10470 Abandonment of diversion structure ABQ944.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to execute a Letter Agreement with ODOT for the purpose described in Section 1, in the amount of \$10,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


