* Authorize contract with ING Life Insurance and Annuity Company for Third Party Administration of the City Deferred Compensation Plan (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City currently maintains a governmental 457(b) Deferred Compensation Plan (Plan) pursuant to Section 457 of the Internal Revenue Code (IRC).
- 2. In February 2013 the City conducted a Request for Proposal for Third Party Administration (TPA) recordkeeping, education, communications and investment related services for the City of Portland's Deferred Compensation Plan.
- 3. Whereas the City of Portland has selected ING and wishes to engage ING as an administrative service provider to facilitate the administration of the Plan by providing services that shall include without limitation accounting for deferrals or contributions, disbursement of funds, withholding of taxes, investment education, retirement counseling, investment of assets in the appropriate Plan investment options and proper recordkeeping of participant accounts; and
- 4. Whereas the City of Portland has selected certain investment products offered or otherwise made available by or through ING or the Broker-Dealer respectively for the investment of the Plan's assets; and
- 5. Whereas ING wishes to provide such administrative services to the Plan

NOW THEREFORE, the Council directs:

a. The Mayor and City Auditor are hereby authorized to execute a contract with ING Life Insurance and Annuity Company in a form substantially in accordance with the contract attached hereto as Exhibit A to the original Ordinance, and by reference made a part hereof.

Section 2. The Council declares that an emergency exists because delay would interrupt recordkeeping processes; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
