## ORDINANCE No. 186279

\*Authorize a Supplemental Intergovernmental Agreement with the Oregon Department of Transportation for the design and construction of the NE 102nd Ave: NE Glisan to SE Washington Phase II project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On November 5, 2010, the Oregon Department of Transportation (ODOT) awarded the Portland Bureau of Transportation a grant to fund the 102<sup>nd</sup> Ave. NE Glisan St SE Washington St PH2 project.
- 2. On January 19, 2011, Council approved Ordinance No. 184371, which authorized grant funding for the total anticipated cost for engineering of the project, Contract No. 3000257.
- 3. This Supplemental Intergovernmental Agreement with ODOT will replace Contract No. 3000257. A key change in the agreement is that the City, as a Certified Local Public Agency, will be allowed to advertise, bid and award this federal-aid project through the City's Procurement Office. Under the previous agreement, this advertisement, bid and award process would have occurred through ODOT's Office of Procurement.
- 4. This project is in the FY 2013/14 budget. The grant is identified as the NE 102nd Ave: NE Glisan to SE Washington Phase II.
- 5. The Bureau's level of confidence in the cost estimate for this project is high. The project is ready to go to bid and we have a final estimate.

## NOW, THEREFORE, the Council directs:

a. The Mayor is hereby authorized on behalf of the City of Portland to enter into a Supplemental Intergovernmental Agreement with the Oregon Department of Transportation for the design and construction of the NE 102nd Avenue Project Phase II, in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because this project will begin construction in 2013, design has to start this fiscal year to use the federal funds as soon as the ordinance is passed and other projects need to start design now to be able to bid during the next construction season; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
