A positive impact is expected, because the Age-Friendly Portland Action Plan has been developed to improve the lives of all ages and communities in the greater Portland metropolitan area.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The Action Plan was developed based on: Baseline assessment of Portland's age friendliness conducted as part of the World Health Organization (WHO) Global Age-Friendly Cities project conducted in 2007; Multnomah County's Task Force On Vital Aging report titled *Everyone Matters: A Practical Guide to Building a Community for all Ages (2007);* The City of Portland's *Portland Plan (2012)*, including the subsection "Portland is a Place for All Generations"; A PSU Master of Urban and Regional Planning workshop project titled "Toward an Age-Friendly Portland"; and participation by members of the Advisory Council representing various key organizations and community interests.

- c) How did public involvement shape the outcome of this Council item? In 2010, the City of Portland partnered with the Institute on Aging (IOA) at Portland State University to apply for membership to the WHO Global Network of Age-Friendly Cities. Since that time, the IOA, in collaboration with The Age-Friendly Portland Advisory Council, has conducted further research about age-friendly features and barriers in developing this Action plan to make Portland a more age-friendly city.
