The City of Portland ordains:

Section 1. The Council finds:

1. Open 4 Business Productions, LLC (Company), is currently filming Season 3 of the television series "GRIMM" in the Portland metropolitan area.
2. The Company would like use the name, "Portland Fire & Rescue" and its official emblem/insignia/seal, uniforms, badges and any signage and any and all trademarks, trade names, logos, copyrights or other proprietary trade designations appearing thereon (Intellectual Property).
3. Portland Fire & Rescue is willing to allow the Company to use its Intellectual Property, at no cost, subject to the conditions identified in the Contract attached as Exhibit A.

- a. The Commissioner in Charge is authorized to execute a contract with Open 4 Business Productions, LLC as outlined in a form substantially in accordance with the contract attached as Exhibit A.
