

ORDINANCE No. 186307

Amend Intergovernmental Agreement with Oregon Department of Transportation for SW Moody Ave Project: SW River Pkwy to SW Hamilton Ct to extend the completion date and project boundary (Ordinance; amend Contract No. 30001376)

The City of Portland ordains:

Section 1. The Council finds:

1. On April 21, 2010, City Council passed Ordinance No. 183696 accepting a grant from the Oregon Department of Transportation for the SW Moody Avenue: SW River Parkway to SW Gibbs project, Contract No. 300001376.
2. This grant has provided funding for the SW Harbor Dr/SW River Parkway improvements and the SW Moody Avenue Project: SW River Parkway – SW Gibbs Street.
3. This amendment will extend the completion time of the original Intergovernmental Agreement to allow for more time to complete the identified work and will extend the project boundary south to SW Hamilton Court.

NOW THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is hereby authorized to execute an amendment to Contract No. 30001376 with the Oregon Department of Transportation, in a form similar to the contract attached as Exhibit A.
- b. The Commissioner-in-charge is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.


