Re: Reappoint community members to serve on the PPB's Police Review Board

In 2010, Portland City Council amended City Code 3.20 which governs the processes and make up of Portland Police Bureau's performance and use of force review boards. As part of the changes approved by Council, the Police Bureau selects community members for the Police Review Board from a pool of volunteers recommended by the City Auditor and appointed by City Council.

My recommendations for reappointment are listed below, and brief biographies are attached. Staff from the Auditor's Independent Police Review division, a member of the Citizen Review Committee, and a Police Bureau member assisted in selecting these community volunteers to participate in Police Review Boards convened after October 31, 2013. If confirmed by Council, their term begins November 1, 2013 and ends October 31, 2016.


1. **Carlos Calderon-Marcial** resides in Portland and is self-employed investments professional. He has over 30 years in banking and finance experience and is currently devoting some of his time to community development. He has reapplied to serve an additional term on the Portland Police Review Board. He is currently serving a second term as the public member of the Oregon State Bar's Client Security Fund, and completing his first term as a public member of the Bar's Disciplinary Board.
2. **Edward Hershey** Edward Hershey retired in 2012 as Communications Director for Service Employees International Union Local 503 and is now principal of Edward Hershey & Associates, communications consultants. He previously worked as a reporter for Newsday covering criminal justice issues, and he was New York City's Assistant Commissioner of Corrections and an Ithaca, NY city alderman. He has also worked as a consultant to the Multnomah County Sheriff regarding County corrections and is author with Det. Capt. Frank Bolz of "Hostage Cop" (Rawson-Wade, 1979).
3. **Rob Kodiriy** is a Finance/Business Services Manager for the Multnomah County Department of County Human Services, providing departmental oversight, support, and managing staff. Previously he was a Senior Fiscal Analyst for the State of Oregon. Prior to that, he managed a department within Immigrant and Refugee Community Organization (IRCO). He speaks multiple languages and volunteers as a way to contribute to the Portland community.
4. **Diane Rollo-Whiting Marsh** is a surgical nurse at Oregon Health and Science University. Her practice involves her with large numbers of indigent persons and a broad spectrum of the community. She has served as a community member on prior Portland Police Bureau review boards and believes that in doing so, she has served as a public voice to improve the community-police relationship.
5. **Anthony McNamer** is a partner of McNamer and Company, owner of Expunged Records, and an attorney who represents, among other clients, hip-hop artists. He has traveled extensively and lived in Samoa and also in Spain. A Portland native, he attended public schools in North and Northeast.
6. **Patrick Messinger** is a retired owner of a residential property management business. He has been a board member or chairperson of the Concordia Neighborhood Association, Northeast Coalition of Neighborhoods, and the advisory council to the Foster Grandparent Program of Metropolitan Family Services. He also has served as a community member on prior Portland Police Bureau review boards, and views that experience as giving back to the community.
7. **Grace Reed** is retired with continued experience in mediation, education, drama therapy, and addiction counseling. She has training and experience in conflict resolution, and she has worked with at-risk individuals and families and with youth dealing with addictions. She has also served on the Mayor's Gang Violence Task

Force, volunteered at Outside/In, and founded the organization, "Alaskans Against Violence."

8. **Lewellyn Robison** is a retired U.S. Customs Officer. She has traveled extensively and lived in Germany and Saudi Arabia. She has served as a member of the Citizen Review Committee from 2004 to 2010, and served on the Police Review Board for several years. She has found both experiences challenging and a worthwhile way of giving back to the community; she is the President of my Homeowners' Association and volunteers at Multnomah County Library.
9. **Charles Rosenthal** now serves on the PRB. He is a retired computer engineer, consultant, and manager. He has served on several boards, committees, and commissions for the City of Portland and Multnomah County, including the Fire and Police Disability and Retirement Board, the Tax Supervising and Conservation Commission, and the Public Utilities Review Board. He has also been on advisory boards for the PSU Engineering School since 1998.
10. **Wilson Sulman** is a retired estimator who worked with mechanical contractors. He served in the United States Navy as a radar operator, and he also did a brief stint on shore patrol. He has volunteered with the Salvation Army distributing food and toys, and he has been involved with his home owner's association working on neighborhood livability concerns, and is serving his second term on the PRB.
