Metro has established the Nature in Neighborhoods grant program with the purpose of funding community projects throughout the metropolitan region. Notwithstanding any statements or inferences to the contrary, Metro neither intends nor accepts any (1) direct involvement in these projects; (2) sponsorship benefits or supervisory responsibility with respect to the events or services funded; or (3) ownership or responsibility for care and custody of the tangible products which result from the projects.

THE PARTIES AGREE AS FOLLOWS:

ARTICLE I SCOPE OF WORK

Contractor shall perform all activities described in the Scope of Work attached hereto as Exhibit "A" (the "Work").

ARTICLE II TERM OF CONTRACT

The term of this Contract shall be for a period commencing upon contract execution through and including July 1, 2015.

ARTICLE III CONTRACT SUM AND TERMS OF PAYMENT

Metro shall compensate the Contractor for performance of the Work as described in Exhibit "A." Metro shall not be responsible for payment of any materials, expenses or costs other than those that are specifically described in Exhibit "A."



ARTICLE IV LIABILITY AND INDEMNITY

Contractor is an independent contractor and assumes full responsibility for the performance of the Work and the content of its work and performance of Contractor's labor, and assumes full responsibility for all liability for bodily injury or physical damage to person or property arising out of or related to this Contract subject to the conditions and limitations of the Oregon Constitution, Article XI, Section 9 and the Oregon Tort Claims Act (ORS 30.260 to 30.300). Contractor shall indemnify and hold harmless Metro and Metro's agents and employees, from any and all claims, demands, damages, actions, losses, and expenses, including attorneys' fees, arising out of or in any way connected with Contractor's performance of this Contract. Contractor is solely responsible for paying Contractor's subcontractors. Nothing in this Contract shall create any contractual relationship between any subcontractor and Metro.

ARTICLE V TERMINATION

Metro may terminate this Contract upon giving Contractor seven (7) days written notice. In the event of termination, Contractor shall be entitled to payment for work performed prior to the date of termination. Metro shall not be liable for indirect or consequential damages. Termination by Metro will not waive any claim or remedies it may have against the Contractor.

ARTICLE VI

Contractor shall purchase and maintain at Contractor's expense, the following types of insurance covering the Contractor, its employees and agents.

A. Commercial general liability insurance covering personal injury, property damage, and bodily injury with automatic coverage for premises and operation and product liability shall be a minimum of \$1,000,000 per occurrence. The policy must be endorsed with contractual liability coverage. <u>Metro, its elected</u> officials, departments, employees and agents shall be named as an ADDITIONAL INSURED.

B. Automobile bodily injury and property damage liability insurance. Insurance coverage shall be a minimum of \$1,000,000 per occurrence. <u>METRO,</u> <u>its elected officials, departments, employees, and agents shall be named as</u> <u>an ADDITIONAL INSURED.</u> Notice of any material change or policy cancellation shall be provided to METRO thirty (30) days prior to the change.

This insurance as well as all workers' compensation coverage for compliance with ORS 656.017 must cover Contractor's operations under this Contract, whether such operations are by Contractor, by any subcontractor, or by anyone directly or indirectly employed by Contractor or any subcontractor.

Contractor shall provide METRO with a certificate of insurance complying with this article and naming METRO as an additional insured within fifteen (15) days of execution of this Contract or twenty-four (24) hours before services under this Contract commence, whichever date is earlier.

In lieu of the above, Metro will accept evidence of a self-insurance program. Contractor shall name METRO as an additional insured within (15) days of execution of this Contract or twenty-four (24) hours before services under this Contract commence, whichever date is earlier.

Contractor shall not be required to provide the liability insurance described in this Article <u>only if an express exclusion relieving Contractor of this requirement is contained in the</u> Scope of Work.

ARTICLE VII PUBLIC CONTRACTS

[Contractor shall comply with all applicable provisions of ORS Chapters 187, 279A, 279B and 279C. All conditions and terms required to be inserted into public contracts in the state of Oregon pursuant to any provisions of ORS Chapters 279A, 279B and 279C are hereby inserted by reference into this Contract and made requirements of this Contract as if such provisions were separately enumerated herein.

In particular, for public works subject to ORS 279C.800 to 279C.870, Contractor and every subcontractor shall comply with ORS 279C.836 by filing a public works bond with the Construction Contractors Board before starting work on the project, unless exempt under that statute.

ARTICLE VIII ATTORNEY'S FEES

In the event of any litigation concerning this Contract, the prevailing party shall be entitled to reasonable attorneys' fees and court costs, including fees and costs on appeal to any appellate courts.



ARTICLE IX SUBCONTRACTORS

Contractor shall contact Metro prior to negotiating any subcontracts and Contractor shall obtain approval from Metro before entering into any subcontracts for the performance of any of the services and/or supply of any of the goods covered by this Contract. Metro reserves the right to reasonably reject any subcontractor or supplier and no increase in the Contractor's compensation shall result thereby. All subcontracts related to this Contract shall include the terms and conditions of this Contract. Contractor shall be fully responsible for all of its subcontractors as provided in Article IV.

ARTICLE X RIGHT TO WITHHOLD PAYMENTS

Metro shall have the right to withhold from payments due Contractor such sums as necessary, in Metro's sole opinion, to protect Metro against any loss, damage or claim which may result from Contractor's performance or failure to perform under this Contract or the failure of Contractor to make proper payment to any suppliers or subcontractors. If a liquidated damages provision is contained in the Scope of Work and if Contractor has, in Metro's opinion, violated that provision, Metro shall have the right to withhold from payments due Contractor such sums as shall satisfy that provision. All sums withheld by Metro under this Article shall become the property of Metro and Contractor shall have no right to such sums to the extent that Contractor has breached this Contract.

ARTICLE XI SAFETY

If services of any nature are to be performed pursuant to this Contract, Contractor shall take all necessary precautions for the safety of employees and others in the vicinity of the services being performed and shall comply with all applicable provision of federal, state and local safety laws and building codes, including the acquisition of any required permits.

ARTICLE XII INTEGRATION OF CONTRACT DOCUMENTS

All of the provisions of any proposal documents including, but not limited to, Requests for Proposals, Proposals and Scopes of Work that were utilized in conjunction with the award of this Contract are hereby expressly incorporated herein by reference. Otherwise, this Contract represents the entire and integrated agreement between Metro and Contractor and supersedes all prior negotiations, representations or agreements, either written or oral. This Contract may be amended only by written instrument signed



by both Metro and Contractor. The law of the state of Oregon shall govern the construction and interpretation of this Contract.

ARTICLE XIII ASSIGNMENT

Contractor shall not assign any rights or obligations under or arising from this Contract without prior written consent from Metro.

The GRUNT pipeline connects at-risk teens to nature through year round environmental education, stewardship, recreation and employment. Our goal is to diversify our bureau and the environmental field by getting urban youth interested in nature and environmental careers and by providing the skills and experiences that they will need to be successful. In FY 13-14, we will serve 175 youth (adding 40 new graduates to the 135 who joined the program between 2008 and 2013), complete 600 hours of stewardship, and employ at least 40 youth with PP&R City Nature.

GRUNT partners with 22 public schools and organizations that serve culturally diverse and/or economically disadvantaged communities. These partners help us recruit and retain students who need opportunity in order to realize their dreams of working for the environment. Our 135 current graduates are a diverse crew: 69% are people of color, 56% speak English as a Second Language and 82% participate in the Free & Reduced Lunch Program. They live in N, NE, SE and outer SE Portland. We provide year round programming for these youth, whose ages range from 13 to 22. GRUNT is designed to provide long-term mentoring and connections to careers, so once they graduate from the program, many choose to stay connected for years.

The greatest goal of this program is to see more diverse individuals choosing an environmental career path. Although it is too early to tell how effective this will be long-term, several members or our 2008 & 2009 cohorts have chosen environmental education or biology as fields of study. Six are working regularly as lead environmental educators with PP&R. Others are continuing to volunteer with environmental organizations that they interned with through GRUNT. Whether or not GRUNT graduates choose an environmental career, they will be more informed citizens about urban nature and environmental concerns in the Pacific NW. Evidence that GRUNT graduates

share the knowledge that they have learned about the environment is the face that 8 younger siblings or cousins have joined the program. Environmental stewardship and employment becomes a family tradition. GRUNT also has positive impacts on health. The average teen spends 6-8 hours a day in front of a screen. GRUNT youth are outdoors, hiking, working and engaged in their local natural areas.

The GRUNT pipeline connects teens to nature through environmental education, stewardship, recreation, and employment. Our goal is to diversify our bureau by getting urban youth interested in nature and environmental careers, and by providing the skills and experiences that they will need to be successful. Here is how the pipeline works:

8th Grade - Jr. GRUNT

We recruit at-risk 8th graders from North, Northeast and outer SE Portland. They participate in a 6 week fall program and 5 day spring break program which incorporate hands-on environmental science learning and leadership skill building. All sessions occur outdoors in Portland's parks and natural areas.

9th and 10th Grades – Jr. GRUNT 2.02

8th grade graduates rise to the next level of the program, which includes a 4 week summer program, 7-day backpacking trip, and school year opportunities to volunteer in stewardship and environmental education programs. All students create a resume and some are selected for paid work with the Youth Conservation Crew.

<u>10th Grade – GRUNT</u>

This is a 65 hour volunteer naturalist and leadership training program. All graduates earn paid work with Portland Parks & Recreation's Youth Conservation Crew (YCC), Summer Nature Day Camp or Nuts About Nature preschool.

11th Grade until Age 22

Graduates of both programs have access to long-term mentoring which includes year round professional development and paid internship opportunities.

Roles and responsibilities of each partner:

- All Hands Raised (9th Grade Counts Collaborative) provides bus passes for youth during summer program, Marylhurst University mentors from the Masters of Teaching program, and an AmeriCorps member.
- Laura Bulinski (Jefferson High School), Jill Semlick (Madison High School), Hacienda CDC and SAFRN connect us to students for recruitment and identification of youth who would benefit most from our programs. We stay in communication all year long to discuss progress of youth.
- Darina Supina graduated from GRUNT in 2009. She currently serves as a volunteer advisor to the program. She speaks with program participants about career and college options and trains new GRUNT graduates who work with Nature Day Camp or Nuts About Nature Preschool.

 - Creates new or expands existing relationships between partners and/or organizations.
 - Connects people to their watershed and/or teaches people about watershed health.
 - Preserves and restores fish and wildlife habitat in local communities; connects to larger conservation initiatives.
 - Supports nature education and hands-on learning for school-age children.
 - Improves the ability of underserved communities particularly low-income people and communities of color to experience and access nature.

The GRUNT program aligns with Metro's Nature in Neighborhoods program goals in that it:

- Has a deep network of partnerships. We partner with 22 public schools and partner organizations that serve culturally diverse and/or economically disadvantaged communities. These partners help us identify which students need the opportunities provided by GRUNT the most. Two local businesses have donated outdoor gear (including jackets, hats, socks and boots) so that our youth can comfortably explore nature. All Hands Raised provides a great deal of support to our summer Jr. GRUNT program through bus passes for youth, an AmeriCorps staff person, and resources.
- **Connects underserved youth to nature**. Through targeted recruitment, we build a diverse program economically, culturally, linguistically and racially. Demographics of current participants: 69% are people of color, 56% speak English as a second language and 82% participate in the Free & Reduced Lunch program.
- Provides year-round nature-education experiences for youth. GRUNT participants and graduates venture outdoors with us year round, so that they may experience all that our unique ecology has to offer, as well as become comfortable in nature in all seasons. Our curriculum is tied to Oregon State Science standards and explores watersheds in multifaceted ways: water quality testing, macroinvertebrate studies, amphibian monitoring, watershed models, native and non-native plants, erosion, discussions of how our personal actions impact watersheds, and recreation in and around our watersheds. We visit all Portland watersheds on the east side of the river and some on the West side.
- Promotes a stewardship ethic. GRUNT works with PP&R Stewardship coordinators to plant native plants, remove invasive species, build trails and educate the public about nature. In late winter / early spring, we work with the park ecologist to monitor amphibians in Oaks Bottom Wildlife Refuge.

We will serve a total of 170 youth in fiscal year 2013-14. Our participants are youth, ages 13 – 22. While continuing to work with graduates from previous years, we recruit at least 18 new 8th graders for Jr. GRUNT and 18 new 10th graders for GRUNT each year. These students come to us through the assistance of counselors and science teachers at schools and organizations in culturally diverse communities. These include: Jefferson High School (HS), Roosevelt HS, Madison HS, David Douglas HS, Benson HS, Cesar Chavez Middle School (MS), George MS, King K-8, Open Meadow MS, Hacienda CDC, NAYA, Latino Network, Rose CDC, IRCO Asian Family Center and the Office of Youth Violence Prevention (serving gang-affected youth).

Educational aspects of our programs include: job readiness training, environmental science learning and social skills.

Job readiness training:

By building concrete job skills and a working connection to our parks and natural areas, GRUNT youth become attractive candidates for jobs within our bureau. We keep them updated about job openings and provide resources, support and professional development that improve their hireability.

Environmental science skills:

Our hands-on, inquiry based and relevant curriculum engages even the most reticent student. Topics include: amphibians, water quality, macroinvertebrates, fungi, salmon, watersheds, native and non-native plants, ethnobotany, birds and other wildlife.

Social skills

Students learn about and practice the social expectations in a job, including professional language, dress, teamwork and inclusion.

The GRUNT pipeline is closely aligned with PP&R's mission to provide equitable access to nature and to promote health and stewardship. PP&R Director Mike Abbatè describes the GRUNT pipeline as *"making important contributions to our efforts to diversify the bureau; to bring people in contact with the amazing natural world at our doorstep, to have Healthy Parks, and a Healthy Portland....for all!"*

- 5. Describe the project or program outcomes or benefits. How will you define and measure success? If applicable, what is the long-term maintenance strategy for the project?
- Short-term deliverables and measurable outcomes:
- **175 youth** will participate in environmental education, volunteerism, recreation & employment. We served 135 youth in FY 12-13 and expect to recruit 40 in the FY 13-14 cohort. New participants are required to have at least 80% attendance in order to graduate. Youth from older cohorts will show sustained involvement through employment, volunteerism or by attending a professional development workshop or outdoor enrichment activity.
- **40 youth will gain paid employment** with the Youth Conservation Crew, Nature Day Camp, Nuts About Nature preschool or another PP&R program as a result of their work with GRUNT.
- 344 healthy lunches will be provided to teens during volunteer experiences.
- Teens will complete 600 man-hours of stewardship.
- Long-term measurements of success (we collect this data each year):
- How many GRUNT graduates completed high school?
- How many are studying environmental sciences or education in college or university?
- How many are pursuing natural resources careers?
- How many are employed by PP&R?

How many have recommended that family or community members join GRUNT?
 Benefits of GRUNT:

- Engages diverse participants in environmental stewardship & employment participants are recruited from schools and community organizations in diverse neighborhoods with 75% or greater Free & Reduced Lunch participation. We work closely with counselors, teachers, and partners to identify teens at risk for dropping out of school, and who would benefit from the long-term mentoring and environmental training provided by GRUNT.
- Improves health of participants programs take place outdoors in parks & natural areas where youth are engaged in physical activity such as hiking, kayaking, and natural areas restoration. We also teach healthy eating habits.
- Supports academic success Our environmental science curriculum is directly correlated to Oregon State Science Standards. We make the material accessible to all types of learners through hands-on and relevant activities including amphibian research, water quality testing and native plant walks. In the words of one 2012 participant: *"It [Jr. GRUNT] helped me get a step up on other kids in my grade because they aren't learning as much science."* This is especially important because we recruit diverse youth from underserved backgrounds. According to Portland Public Schools, teens of color and from low-income
- homes are facing high unemployment and low high school graduation rates. We assess learning through pre- and post tests. Short-term learning is assessed at the beginning and end of a lesson. Longer term learning is assessed using a pre-test at the beginning of a program, and a post-test at the end of the program (6 to 10 weeks later). We differentiate assessment based on the group's English language skills. Tests can be written, oral, or done in pairs.
- Increases teens' knowledge of career & college options teens are exposed to a wide variety of career choices within natural resources. They meet and interview professionals, gain experience through internships, summer work and volunteer opportunities, and tour colleges.
- Puts disadvantaged teens on an equal playing field for employment -- our rigorous job skills and work readiness curriculum prepares youth to perform high quality work and provides experiences to build a strong resume. In the words of Sonja Rosas, a graduate from the 2009 GRUNT class, who recently became employed with an environmental organization: "Now that I'm out of GRUNT, I realize how brilliant it was! [The organization I'm working for] is not diverse and the way hiring is done, it excludes a lot of people. Because of my experiences with Parks, I am on an equal playing field."

Personal services (salaries / administration)

• <u>Crew Leaders -</u> Programs are taught by part time environmental education staff. Three out of five of our crew leaders graduated from the GRUNT program in 2009 and represent the cultural groups of the students we serve. (Crew Leaders are paid \$17.82 / assistants are paid between 9/hr and 13/hr.)

Program Coordinator

Kelly Rosteck is a permanent full time employee and is responsible for GRUNT, Jr. GRUNT and many associated programs. She spends about half of her time coordinating GRUNT programs and providing support (1,600 hours @ \$25/hr).

- <u>Stewardship Coordinators PP&R</u> has three permanent stewardship coordinators who plan and lead all stewardship activities (67 hours @ \$30/hr).
- No lvy League (a crew of Youth Conservation Crew) Provides paid natural resources work for teens, including graduates of the Jr. GRUNT and GRUNT programs. While funding for the YCC is not secured, the No Ivy League has external funding and is secured. A crew costs \$24,000 to run.

Volunteer Labor

- Darina Supina (GRUNT '09) volunteers to fulfill a requirement of her program at Portland Community College. She advises on curriculum and materials, leads nature walks and trains teens who will be working with Nuts About Nature preschool and Nature Day Camp
- <u>Robel Haile (GRUNT '10)</u> volunteers to lead Jr. GRUNT during breaks from University of Oregon. He does this because he loves it and also to improve his resume for scholarships and programs.

Professional services (activity / amount)

All of these recreation activities connect teens to nature in a deeply personal way; our youth would not have access to these types of experiences without GRUNT.

- Backpacking trips (2 trips at \$1,700 each with Big City Mountaineers) youth embark on a 7 day intensive trip, in which they practice Leave No Trace in the backcountry, explore their personal boundaries and develop leadership skills.
- Kayking trips (2 trips at \$500/each with Adventures Without Limits)– Paddling around Ross Island is challenging, fun, and provides a platform for exploring Willamette Valley watershed issues.
- Ropes Course (1 trip at \$700 with Synergo) Leadership workshop on the Sandy River.
- Bug Chicks Workshops (2 workshops at \$200/each)— The Bug Chicks teach hands-on invertebrate workshops and share information about the diversity of careers in the environmental field.

Materials and supplies:

- Printing brochures, posters and flyers are used to recruit students; Field journals are printed for students to take notes in and journal (40 journals at \$3/each)
- Uniforms (40 sets at \$35 per youth) each youth receives a shirt and a hoody to wear while working and learning in natural areas.
- Food for youth many youth do not have access to healthy food when they are not at school; we provide simple, healthy meals at our programs (\$45 to serve up to 18 youth per day)
- **Reusable water bottles** (40 bottles at \$5/each from Next Adventure) each student is given a bottle as a part of our sustainability initiative.

Transportation / travel

• Vans / Gas – (1390 miles at \$0.82/mile) We transport teens to natural areas in 15 passenger vans owned by the City, but must pay for gas & maintenance

Other:

- 9th Grade Counts is a key partner and provides support to our summer program.
- WMSWCD awarded us \$8,141 to support the GRUNT pipeline
- No Ivy League (PP&R City Nature) will provide summer employment for at least 6 GRUNT teens this summer.

Dear NIN Proposal Review Team;

As a local practitioner in the area of natural area stewardship, and as the mother of a teen who has immensely benefitted from participation in the Portland Park's Jr. GRUNT program, I am pleased to offer this letter of support for their proposal for Nature in the Neighborhoods funding.

The programming offered through this program provides a unique overlap of education, mentorship, college/career planning, natural area stewardship, and outdoor recreation experiences for teens at a critical development stage. This comprehensive program serves to develop leadership, confidence, stewardship skills, and a greatly increased appreciation for interacting with nature. I find the core goals of the program to be one of the best representations of The Intertwine's goals for increasing Metro resident appreciation for and use of our natural area network.

Having experienced the benefits of the programming first-hand through my son's involvement last summer, I can attest to the ability of the programming to engage, educate, and motivate young teens struggling with focus and motivation. The exposure to outdoor adventure; the development of competencies in hiking. camping, kayaking, mountain biking; and the instillment of appreciation for the benefits and stewardship needs of open spaces was an experience that proved more compelling to my son than video game playing with his neighborhood friends. He was so drawn to the role model staff and new experiences everyday during his 4-week Jr. GRUNT program last summer, that afterwards he become motivated to find opportunities to work with younger kids in outdoor settings, and now volunteers enthusiastically with Portland Parks. This was a shocking development for parents who had vet to see their son invest effort in school. chores, or recreational opportunities not involving paint guns or electronics. In my experience, the program provides an unparalleled opportunity for urban teens to learn their physical potential, gain a comfort level in unfamiliar terrain (or in unfamiliar waters), and begin to really value nature at a personal level.

As the Natural Resources Program Coordinator for Gresham, I have the opportunity to work in a program that is largely supported by the efforts of community volunteers to implement biodiversity surveys, habitat improvements, and natural area restoration. We've seen the value directly in getting kids out in the field, increasing their connection to their local resources. The Jr. GRUNT provides a concentrated breadth of natural area experiences. In an era of continuing budget cuts that have reduced or eliminated programming critical for supporting youth and engaging the community in natural area stewardship, I find the Jr. GRUNT program to be a unique model that I advocate for replicating in east county, and across the Metro area. While we regionally see dwindling opportunities for youth in Outdoor School, Police Activities League, and local community recreation programming, it has been entirely inspiring to see the Jr. GRUNT program develop, providing critical opportunities for youth to expand their understanding and appreciation for our natural area network. The program structure is unique in that teens cannot help but come to understand the interplay between personally stewarding natural areas and personally benefitting from natural areas. It's not just an investment in these individual teens, it's an investment in future rate payers who will be more inclined to support public initiatives for natural area acquisition and stewardship.

This program invests in our young teens' health, joy, and love of the outdoors, while simultaneously instilling a stewardship ethic and personal pride of accomplishment from the challenges presented to them by the exceptional program staff. With such a clear relevance to the goals of Metro and The Intertwine, I most enthusiastically support their Nature in the Neighborhoods grant proposal, and would also welcome the chance to connect with Metro staff and other local jurisdictions in the near future to discuss opportunities to grow the program beyond the Portland jurisdictional boundaries. The results I've experienced personally lead me to believe that we have not yet had in our Metro area an equally successful model for creating such a wealth of personal connections to our natural areas, and the benefits of those connections for the teens fortunate enough to participate in Jr. GRUNT will undoubtedly last a lifetime.

Youth give back to their community by participating in environmental stewardship projects; this fosters a sense of "ownership" of local parks while teaching a positive work ethic. "At first I just went to Jr. GRUNT because it was something to do on Saturdays, but it helped me care more about the environment and now caring about nature is like habit." -Alli (10th grade)

HIGHLIGHTS

- 25 Jr. GRUNT graduates (now in the 9th and 10th grades) are still actively participating in the Jr. GRUNT 2.0 program.
- 6 students volunteered as either assistants with the Jr. GRUNT 8th grade program, the Nature's Playground program, or the Teen Environmental Adventures program and also with our holiday wreath fundraiser and in the Environmental Education office.
- 3 students were hired by PP&R this summer; 2 worked with the Youth Conservation Crew's No Ivy League, and 1 worked as a counselor at Environmental Education's Summer Nature Day Camp.
- 10th Grade Jr. GRUNT students are able to apply to the GRUNT program this year, offering even more
- opportunities for paid work experience.

ENVIRONMENTAL SCIENCE

We piloted a new evaluation method in Fall 2012. We plan to duplicate this method in order to track our results.

These are the results of the Jr. GRUNT Fall 2012 program.

Jr. GRUNT teaches Oregon State Science Standards

METHODS:

In order to assess environmental science knowledge attainment, we gave out short quizzes to all participants at the beginning of each day. Each quiz had 4-5 questions that relate directly to Jr. GRUNT's learning goals and Oregon State Science Standards. At the end of the season, all students took each quiz over again in a cumulative exam. Each question was evaluated individually and we calculated the percentage correct for pre and post test results.



*To present the data for this graph, we matched questions with the Science Standards to which they applied. If multiple questions pertained to the same standard, the pre and post average percentage correct for each question is shown.

RESULTS:

JR. GRUNT

In a comparison of test results comparing pre and post knowledge of science topics, there is a percentage increase in each Science Standards category. After analysis of pre and post results for each question, we would like to further refine the quizes to incorporate more multiple choice questions and less fill-in-the-blank questions. In addition, we will re-word or change questions that we do not feel address our learning goals, cause confusion for the youth, or those questions that youth seemed to have a higher pre-knowledge of.
