Section 1. The Council finds:

- 1. In 2008, Ordinance No. 182405 authorized a concession contract with Cumpston Bros., Inc. for concession services at Eastmoreland Golf Course. Said contract will expire on December 31, 2013.
- 2. Portland Parks & Recreation is satisfied with the concession operation under this contract and believes it will be advantageous for the City to extend said contract. The Portland Parks & Recreation Golf Advisory Committee has also recommended to the Director of Portland Parks & Recreation that this contract be renewed.
- 3. Consistent with the contract terms, Cumpston Bros, Inc. have requested a renewal of their golf concession contract for 5 years.
- 4. Consistent with City Code, Chapter 5.33.50, the Director of Portland Parks and Recreation recommends the renewal of the contract for one additional five year term.

NOW, THEREFORE, the Council Directs:

a. The Commissioner-in-charge of PP&R is hereby authorized to execute the Contract Amendment attached to this Ordinance, and the Contract Amendment shall be approved as to form by the City Attorney.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the in the provision of golf services for the users of Eastmoreland Golf Course; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
