## ORDINANCE No. 186316

Authorize a contract with Carollo Engineers, Inc, for professional services for the design of the Portsmouth Forcemain Drain-Back Improvements No. E10484 for \$225,700 (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of a consulting engineering firm to provide professional services for the Portsmouth Forcemain Drain-Back Improvements No. E10484.
- 2. Consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (RFP BESI42). The consultant selection committee recommended that Carollo Engineers, Inc be retained to provide the required professional engineering services.
- 3. The estimated cost is \$225,700. Funds are available in the SICSO Force Main 3 Drain-back Improvements, Bureau of Environmental Services, WBS Element E10484.
- 4. M/W/ESB participation is \$31,600 or 14% of the total contract amount.

## NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with Carollo Engineers, Inc., for the purpose described in Section 1, in the amount of \$225,700.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
