

ORDINANCE NO. 186317 As Amended

*Authorize a grant agreement with Janus Youth Programs, Inc. for \$177,000 to provide shelter beds and treatment for juvenile human trafficking victims from July 1, 2013 to June 30, 2014 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Whereas, the Sexual Abuse Resource Center (SARC) provides extensive support to juvenile human trafficking victims through a 24-hour crisis line, hospital visits, case management, prevention education and outreach, offering support groups, and providing free mental health services; and
2. Whereas, the City of Portland and Multnomah County have joined together to fund shelter beds and treatment for juvenile human trafficking victims at a Janus facility in the City of Portland.; and
3. Whereas, in order to continue to provide a safe place for juvenile human trafficking victims, provide essential treatment services, and fund additional SARC victim advocates, CITY agrees to provide \$177,000 to support Janus; and
4. The FY 2013-14 budget includes funding in the General Fund Special Appropriations for the above grant. The City now desires to make a grant to Janus Youth Programs in an amount not to exceed \$177,000.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into a Grant Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$177,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2013-14 Budget.

Section 2. The Council declares that an emergency exists because a delay in funding could impact Janus' ability to provide continuous safe places for juvenile human trafficking victims and essential treatment services; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


