*Authorize a contract with the lowest responsible bidder for the S.E. 136th Ave: Holgate to Powell Sidewalk Infill Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- In 2012, the Portland Bureau of Transportation (PBOT) began work to identify, design and 1. construct sidewalk infill on busier streets carrying transit in East Portland.
- PBOT has based the prioritization of the projects on East Portland In Motion plans which 2. were adopted by City Council.
- PBOT began design work on S.E. 136th Ave: Holgate to Powell and conducted outreach to 3. property owners and residents.
- The Bureau of Transportation has funds budgeted in FY 12-13 and proposed FY 13-14 for 4. construction, inspection and management of the project.
- The Bureau's level of confidence in the cost estimate for this project is high as the project is 5. defined and engineering plans and specifications are at completion.

NOW, THEREFORE, the Council directs:

- Upon the Council's acceptance of the Chief Procurement Officer's report recommending the a. lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- The Auditor to draw and deliver warrants chargeable to T00321 when demand is presented b. and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the project is a high priority safety improvement project and a delay in authorization will postpone the bidding and construction; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
