ORDINANCE No. 186321

Donate surplus fire apparatus to Sister City Guadalajara, Mexico. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Guadalajara, Mexico (Guadalajara), one of Portland's Sister Cities, has need of a fire engine (Pumper) and fire truck (Truck).
2. Portland Fire & Rescue (PF&R) has a surplus 1981 Seagraves/FWD Pumper with an estimated value of \$2,400 and a 1984 Thibault Rear Mount 100' Aerial Model 100 Truck with an estimated value of less than \$5,000.
3. As authorized by City Code 5.36.010.5.b, PF&R would like to donate this surplus used fire apparatus to Guadalajara.
4. Guadalajara will be responsible for picking up the donated apparatus from PF&R.

NOW, THEREFORE, the Council directs:

- a. Portland Fire & Rescue is authorized to donate a surplus 1981 Seagraves/FWD Pumper and a 1984 Thibault Rear Mount 100' Aerial Model 100 to Guadalajara, Mexico.


