

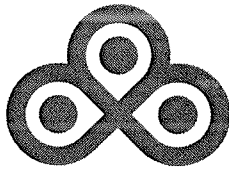

5. **Purpose of Agenda Item:**

The purpose of this Ordinance is to receive City Council approval of the transfer as required by the franchise agreement.

6. **History of Agenda Item/Background:**

Waste Connections of Oregon, Inc. holds two residential solid waste, recycling and composting collection franchises within the City and operates them under the business names of American Sanitary Service, Inc. and Arrow Sanitary Service. They have informed the City of their intention to merge operations of both franchises into the Waste Connections of Oregon, Inc., dba Arrow Sanitary Service franchise in order to reduce redundancies. This action requires Council approval of the transfer per the existing franchise agreement.
