

ORDINANCE No. 186338

Move existing Bureau of Environmental Services fees from the Stormwater Management Manual to the Sewer and Drainage Rates and Charges fee schedule (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. BES has council-delegated authority to maintain and update administrative rules and design guidelines, such as the Stormwater Management Manual and the Sewer and Drainage Facilities Design Manual.
2. A number of fees were included in these administrative rules when they were first adopted by council.
3. Fees should be located in the adopted fee schedule for BES, known as the Sewer and Drainage Rates and Charges.

NOW, THEREFORE, the Council directs:

- a. The Bureau of Environmental Services fee schedule listed as Exhibit A will be effective January 1, 2014.
- b. Exhibit A of this ordinance is binding City Policy.




