Section 1. The Council finds:

1. Approves sole source award to Madison Biosolids, Inc. for biosolids land application services.
2. The established cost is \$675,000 annual estimated cost. Funds are available in the Sewer System Operating Fund, FY 2014 Budget, Bureau of Environmental Services, Cost Center ESWW000007

NOW, THEREFORE, the Council directs:


