ORDINANCE No. 186348

*Pay claim of April Coiteux in the sum of \$18,006, involving the Portland Police Bureau.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. April Coiteux, through her attorney, Tim Quenelle, has filed a lawsuit against the City for damages suffered in an incident occurring on June 20, 2012. In the lawsuit, claimant makes claim for damages from a motor vehicle accident involving the Portland Police Bureau.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$18,006.11, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver checks in the amount of \$10,000.00 made payable to April Coiteux and Tim Quenelle. A second check will be drawn and delivered in the amount of \$6,447.15 made payable to USAA. An advanced medical payment has been made in the amount of \$1,558.96. Total claim settlement is \$18,006.11.
- b. Risk Management Services will execute payment authorizations in the amounts set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


