* Amend contract with Carleton Hart Architecture, PC to increase contract by \$4,990 to provide additional architectural and engineering services for Roof Replacement for Two Police Facilities (Ordinance; amend Contract No. 30002200)

The City of Portland ordains:

Section 1. The Council finds:

- RFP No. FAC018 was issued April 28, 2011 for a contractor to provide architectural and engineering (A/E) services for Roof Replacement for Two Police Facilities (North Precinct and St. John's Training Building). Four proposals were received on May 26, 2011. A selection committee reviewed the responses and recommended award of the contract to Carleton Hart Architecure, PC who was the highest scoring Respondent. Carleton Hart Architecture, PC is a state-certified MBE.
- 2. The agreement amount was \$100,295 with an expiration date of August 21, 2013.
- 3. Amendment No. 1, dated February 9, 2012, increased the contract amount \$24,500 for a total contract amount of \$124,795 to allow for additional A/E services for the re-roof of a city-owned building located at 5420 NE 6th Avenue, Portland, more commonly known as the Walnut Park laundromat building.
- 4. Amendment No. 2, dated April 10, 2013, increased the contract amount \$13,340 for a total contract amount of \$138, 135 to allow for additional A/E services as follows: extension of schedule for roofing installation at the Training Building, extension of schedule for window and cap sheet installation at the North Precinct Facility and boiler replacement at the Walnut Park Laundromat building.
- 5. This amendment increases the Contract amount by \$4,990 and extends termination date to June 30, 2014 to allow for additional A/E services for the Police Facilities Roof Replacement project as follows:

North Precinct Facility

- a. Two (2) additional site inspections of cap sheet installation
- b. Perform moisture testing of North Precinct roof, provide roof plan & memo
- c. Site visit with Soprema (roofing material manufacturer) to evaluate installation issues
- d. Additional time for roof manufacturer's quality issues
- e. Additional site visits for installation quality issues
- f. PRC (Professional Roofing Consultants) letter to Soprema requiring manufacturer's observation of installation

<u>St. John's Training Building</u> Additional detail for bell structure reconstruction

6. The Office of Management and Finance/Facilities Services recommends that Contract No. 30002200 wth Carleton Hart Architecture, PC for A/E services for Roof Replacement for Two Police Facilities be amended substantially in conformance with Exhibit A attached to increase amount by \$4,990 for a new total contract amount not to exceed \$143,125 and extend the termination date through June 30, 2014.

- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the appropriate fund when demand is presented and approved by the proper authorities.
