TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 116071 for the SW Multnomah Blvd Improvements: SW 22nd Ave to SW 40th Ave for the Portland Bureau of Transportation, with a project construction estimate of \$2,220,000.00. The Portland Bureau of Transportation rated the project estimate confidence level as Moderate.

Bids were opened on October 31, 2013, and ten (10) bids were received. The low bid of Tapani, Inc. was deemed responsive to the requirements of the solicitation, and it is recommended that their bid be accepted at the unit price quoted in their bid for a total estimated amount of \$2,126,272.50.

The Portland Bureau of Transportation along with Procurement Services, identified seventeen (17) Divisions of Work as potential M/W/ESB subcontracting opportunities for this project, resulting in \$1,020,742.00 awarded to subcontractors.

- WBE \$50,000.00 performing Hauling Services (Trucking) (Partial)
- ESB \$64,238.00 performing Landscaping and Fencing

Tapani, Inc. has a current City of Portland Business Tax Registration and their EEO Certification is current through July 10, 2015. The company is located in Battle Ground, Washington, and is not a State Certified M/W/ESB Contractor.

Tapani, Inc. is in Full Compliance with the Equal Benefits Program.

Funds are available in the FY 2012-2013 Budget and proposed FY 2013-2014 Budget, Portland Bureau of Transportation, WBS Element T00245.C42.

It is further recommended that a Performance Bond and a Payment Bond each in the amount of 100% of the contract amount be furnished by the Contractor.

It is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
