## 186379 **ORDINANCE** No.

Authorize decrease in the Oregon Department of Environmental Quality Clean Water State Revolving Fund Loan Agreement Number R74164 loan amount by \$450,459 (Ordinance)

The City of Portland ordains:

- Section 1. The Council finds:
  - 1. The mission of the Bureau of Environmental Services (BES) is to protect public health, water quality and the environment. This is accomplished both through traditional sewer system projects and non-traditional work such as revegetation.
  - 2. The Oregon Department of Environmental Quality's (DEQ's) State Revolving Loan Fund Program offers loans for traditional and non-traditional water quality enhancement projects.
  - 3. BES entered into a loan agreement with DEQ (loan number R74164) on 09/19/2003 and completed the Lents Sanitary Sewer Extension project (E06954) funded by the loan on 02/16/2011.
  - 4. This ordinance amends the loan agreement to reduce the loan amount by \$450,459 as remaining loan funds are no longer needed for this project.

## NOW, THEREFORE, the Council directs:

- The Commissioner in Charge is authorized to execute an amendment with DEQ to a. reduce the loan amount of Oregon Department of Environmental Quality Clean Water State Revolving Fund Loan Agreement No. R74164 by \$450,459.
- The Director of the Bureau of Environmental Services is authorized to execute b. any subsequent amendments to DEQ Loan No. R74164, provided such amendments do not increase the City of Portland's financial obligation or risk. Any amendments that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.
