## ORDINANCE NO. 186385

\*Adopt housekeeping amendments to Private For-Hire Transportation Regulations (Ordinance; amend Code Sections 16.40.030, 16.40.460, 16.40.470 and 16.40.480)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Private For-Hire Transportation Code Chapter 16.40 makes reference to the outdated TriMet definition "Fareless Square" in several sections regulating taxi fares. The term "Fareless Square" is no longer current.
- "Downtown Core" is a more accurate and understandable term to describe the area previously known as "Fareless Square".
- Section 16.40.460 should include a reference to the administrative rule definition of "prearranged" transportation.
- 4. Subsection 16.40.480 B was retained in the Code from a previous draft in error, this subsection is inconsistent with Section 16.40.460, and should be removed from the published version of Chapter 16.40.

NOW, THEREFORE, the Council directs:

PCC Sections 16.40.030, 16.40.460, 16.40.470 and 16.40.480 are amended as provided in Attachment A.

The Council declares an emergency exists because it is necessary that these clarifications to Chapter 16.40 be established as soon as possible; therefore, this ordinance shall be in full force and effect from and after its passage by the Council
