Rename a segment of NE Everett Pl lying between NE 97th Ave and NE 99th Ave to NE Everett Ct (Ordinance; C-10035)

The City of Portland ordains:

Section 1. The Council finds:

- 1. A strip of property lying between NE 97th Avenue and NE 99th Avenue was granted to the City of Portland in Document No. 2010-156561, recorded December 10, 2010, for public right-of-way necessary for the NE 97th Avenue Green Street Local Improvement District.
- 2. Ordinance No. 185403, passed by City Council on June 13, 2012, named the section of public right-of-way "NE Everett Place".
- 3. Although City Council approved the ordinance naming the street NE Everett Place, in order to maintain naming integrity, Bureau of Transportation Mapping Department is of the opinion, it would be appropriate to rename this section of street to "NE Everett Court".
- 4. The request complies with the procedures and requirements established in Title 17, Chapter 17.93.050, Council–Initiated Action to Rename a City Street.
- 5. There is minimal cost for staff time associated in processing this ordinance, likely not exceeding \$1,000.00. Funds are available in the LID budget, SAP No. T00407, 2013/14 FY.

NOW, THEREFORE, the Council directs:

- a. The following described City street is hereby renamed NE Everett Court:

 That segment of NE Everett Place located between the east right-of-way line of NE 97th

 Avenue and the west right of way line of NE 99th Avenue as depicted on Exhibit A attached hereto and by this reference made a part hereof. Containing 8,952 square feet, more or less.
- b. The Auditor shall return a certified copy of this Ordinance to the Right of Way Acquisition Section, Bureau of Transportation, for recording in the Multnomah County Deed Records; Right of Way Acquisition shall return the original recorded Ordinance to the Auditor and retain a copy.
