Suzhou

I am pleased to submit for your consideration and acceptance a report from the Portland Suzhou Sister City Association on a recent trip to Suzhou, China.

Portland and Suzhou have been sister cities since 1988; during that time, the rich relationship between the cities has flowered – literally, in the case of our own Lan Su gardens. Across the street from City Hall visitors and Portlanders alike can see the majestic "Suzhou Stone," which is said to bring our city prosperity and peace. Suzhou too has benefitted from the relationship, evident in their strong planning and sustainability models. Two common shared values are a love of art and a love of education.

In October of this year, Mayor Hales led a delegation from Portland to Suzhou, in commemoration of the 25<sup>th</sup> anniversary of the relationship between the cities. He was joined by the president of the PSSCA, Robert Fraser, the incoming president, Cathy Chinn, and past presidents of the association, including James Mei. Lincoln principal Peyton Chapman was also with the delegation; she brought Lincoln high school student Emily Levine who captivated her hosts with her fluency in Mandarin.

The purpose of this presentation on January 8, 2014, at 2:00 is for the some of the members of the delegation to tell the City Council about this trip. The report will cover the history and mission of PSSCA; important facts about Suzhou and its synergy with Portland; the educational components, reflections, and conclusions of the trip from Lincoln's principal (and PSSCA board member) Peyton Chapman; and the RACC-funded grants which were displayed during the trip.

Finally, the presenters will share with the Council the award given to Portland by Sister Cities International, for Economic Development, which will be presented at the US-China Sister Cities Conference in March 2014.
