ORDINANCE No. 186407

*Accept and appropriate a grant in the amount of \$20,000 from the East Multnomah Soil & Water Conservation District's Partners in Conservation Grant program in support of the pipeline of Greenspaces Restoration & Urban Naturalist Team programs. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. Portland Parks & Recreation applied to the East Multnomah Soil & Water Conservation District for a Partners in Conservation grant in the amount of \$20,000 for the GRUNT (Greenspaces Restoration & Urban Naturalist Team) program on January 18, 2013; and
- 2. EMSWCD has notified the City of Portland that it will award a grant for the GRUNT program to Portland Parks & Recreation Bureau in the amount of \$20,000;
- 3. GRUNT is a pipeline of programs serving youth ages 13-22 which connects diverse and low income teens to nature and environmental careers. The EMSWCD grant will allow PP&R to offer the GRUNT program for its 7^{th} consecutive year to engage youth in environmental stewardship, leadership and science, and prepare them for careers in the environmental field. Our long term goal is to contribute to bureau and industry diversity by ensuring that GRUNT participants gain the skills and experiences that they will need to be successful in paid work.
- 4. In FY 13-14 Portland Parks & Recreation will:
 - Engage 175 youth (adding 40 new graduates to the 135 who joined the program between 2008 and 2013) in environmental science, stewardship, recreation, and employment.
 - Oversee completion of 600 person-hours of stewardship by enrolled youth.
 - Employ at least 40 GRUNT graduates (via Youth Conservation Crew, Nature Day Camp, ECO Internships, or Nuts About Nature Preschool) in the City Nature department.
 - Serve at least 360 healthy lunches to youth involved in the GRUNT pipeline.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from EMSWCD's Partners in Conservation grant program in support of the GRUNT program in the amount of \$20,000 and to execute the grant agreement and to execute an intergovernmental agreement in a form similar to the agreement attached as Exhibit A.
- b. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

The Director of Parks & Recreation Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by EMSWCD Partners in Conservation grant, grant # 13-025, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
