*Authorize application to East Multnomah Soil and Water Conservation District (EMSWCD) for a grant in the amount of \$60,000 for Crystal Springs Culverts Removal and Habitat Restoration (Ordinance)

2) Purpose of the Proposed Legislation:

Authorizes the City to apply for grant funding that will allow the City to leverage Grey to Green (G2G) culvert replacement funding that is appropriated to construction for Glenwood and Bybee culvert projects in Crystal Springs.

Passing the ordinance gives the Bureau of Environmental Services (BES) the opportunity to seek \$60,000 in grant funding for construction of Glenwood and Bybee culverts, *the final two of nine fish barriers* that blocks juvenile fish passage, daylights the stream, and restores floodplain and riparian habitat in Crystal Springs.

Local match in the amount of \$60,000 will be provided in the form of salary, benefits and external services in the FY 2013/14 budget and FY 2014/15 proposed budget of the Bureau of Environmental Services. Matching funds are available in the Sewer System Operating Fund, Bureau of Environmental Services, WBS element E10480.

a) What impacts are anticipated in the community from this proposed Council item?

Although the majority of the public involvement and community outreach specific to this ordinance has not yet occurred, this grant request to EMSWCD is part of a broader effort to focus on salmon recovery in one watershed – Crystal Springs. In 2010, BES worked with Reed College, the Sellwood-Moreland Improvement League (SMILE) Neighborhood Association, and adjacent property owners to perform a culvert replacement at SE 28th Avenue. In 2012, BES worked with the U.S. Army Corps of Engineers (USACE) to replace two culverts, remove one, and restore a 1/3 acre site. Currently, BES is working with the Portland Parks & Recreation and USACE to restore Westmoreland Park and replace a culvert at SE Tacoma Street. All of these projects, to-date, have included extensive public outreach.

The bureau anticipates informing and involving the community in the design and evaluation of construction impacts of the Bybee and Glenwood culverts through presentations to the SMILE Neighborhood Association, Eastmoreland Neighborhood Association, Reed Neighborhood Association, the Crystal Springs Partnership, and Union Manor Retirement Center; mailings; and tabling at community events and fairs. Meetings with individual property owners have occurred.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

In 2010, BES involved Reed College, the SMILE Neighborhood Association, Eastmoreland Neighborhood Association, and the Reed Neighborhood Association in the design of the SE 28th culvert. BES anticipates involving the SMILE Neighborhood Association, Eastmoreland Neighborhood Association, Reed Neighborhood Association, the Crystal Springs Partnership, and Union Manor Retirement Center in the design of the Bybee and Glenwood culverts, as well as adjacent property owners. BES is working with the U.S. Army Corps of Engineers, NOAA Fisheries, Metro, the East Multnomah Soil and Water Conservation District, Portland Parks, and TriMet on removing a total of nine culverts throughout the Crystal Springs watershed and restoring Westmoreland Park. All of these projects, to-date, have included extensive public outreach involving numerous groups.

c) How did public involvement shape the outcome of this Council item?

Although the majority of the public involvement and community outreach specific to this ordinance has not yet occurred, this grant request to EMSWCD is part of a broader effort to focus on salmon recovery and restoration in one watershed – Crystal Springs. The bureau anticipates informing and involving the community in the design of the Bybee and Glenwood culverts through presentations to neighborhood organizations listed above, targeted mailings to residents, and tabling at community events and fairs. Meetings with individual property owners have occurred.

d) Who designed and implemented the public involvement related to this Council item?

Public involvement to date has been a joint effort by the BES Science, Fish and Wildlife Division and the Johnson Creek Watershed Team. Ronda Fast and Maggie Skenderian designed and implemented public involvement to-date and will continue to collaborate on future public involvement activities.
