Section 1. The Council finds:

- 1. On November 10, 2010, City Council passed Ordinance No. 184218 accepting a grant from the Oregon Department of Transportation for the North Portland Road and Columbia Boulevard Intersection Development Project, Contact No 30002040.
- 2. This grant provides the funding to complete the planning and preliminary design phase for the North Portland Road and Columbia Boulevard Intersection Development Project.
- 3. This amendment will extend the completion date of the original Intergovernmental Agreement to allow more time to process final billing for the completed project, correct the names of the State and Metro project managers and update the Workers Compensation Liability Insurance language.
