

ORDINANCE No. 186412

\* Accept a grant in the amount of \$45,000 from the Oregon Department of Transportation, Transportation Safety Division and appropriate \$30,000 for FY 2013-14 for the 2014 Safety Belt Overtime Enforcement Grant for sworn personnel overtime (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$50,000 for the 2014 Safety Belt Overtime Enforcement Grant on September 5, 2013; and
2. ODOT has notified the City that it will award a grant for the 2014 Safety Belt Overtime Enforcement Grant to the Police Bureau in the amount of \$45,000; and
3. The Police Bureau Traffic Division will conduct overtime traffic enforcement during Safety Belt Blitz periods established by ODOT Transportation Safety Division (TSD), and as funds allow, additional traffic enforcement coverage deemed appropriate by the Bureau in order to maintain and increase public compliance with Oregon motor vehicle safety restraint laws; and
4. ODOT will reimburse the City a maximum of \$45,000 for sworn personnel overtime hours worked on the 2014 Safety Belt Overtime Enforcement Grant during the grant period October 1, 2013, through September 30, 2014; and
5. Local match, in the amount of \$11,250, shall be provided from City funds in the form of Traffic Division straight time hours in the Bureau's FY 2013-14 and FY 2014-15 budgets; and
6. The Council declares an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOT.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from ODOT for the 2014 Safety Belt Overtime Enforcement Grant in the amount of \$45,000.
- b. The FY 2013-14 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area - PL

Bureau Program Expenses - \$30,000

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by ODOT for the 2014 Safety Belt Overtime Enforcement Grant, OP-14-45-03 PPB, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOT. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
