2) Purpose of the Proposed Legislation:

The Oregon Department of Justice (ODOT) has notified the City that it will award a grant for the 2014 Speed (Multi-Unit Traffic Enforcement) Grant Program to the Police Bureau in the amount of \$15,000. This legislation authorizes the Mayor to accept the grant on behalf of the City. The grant period is October 1, 2013, through September 30, 2014.

ODOT will reimburse the City a maximum of \$15,000 for sworn personnel overtime hours worked on the 2014 Speed (Multi-Unit Traffic Enforcement) Grant Program.
