

**ORDINANCE No. 186430**

\* Accept and appropriate a grant in the amount of \$2,000 from the Target Foundation Public Safety Grant Program for the 2013 Heroes and Helpers event, which pairs safety officials with youth in need to buy holiday gifts for their families (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Police applied to the Target Foundation (Target) for a grant in the amount of \$2,000 for the 2013 Heroes and Helpers event on October 10, 2013; and
2. Target has notified the City that it will award a grant for the 2013 Heroes and Helpers event to the Police Bureau in the amount of \$2,000; and
3. The Target Public Safety Grant Program provides grants to public safety agencies and programs to prevent crime, train and educate law enforcement, and support youth programs and community preparedness; and
4. The Heroes and Helpers event provides an experience for children that will foster a positive relationship with law enforcement officers; and
5. The City wishes to accept Target's funding for the Heroes and Helpers event, which will provide Bureau members with Target gift cards to give to the identified youth. The Youth Services Division will coordinate the events at the City and Jantzen Beach Target stores; and
6. This grant does not require a match.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from Target for the 2013 Heroes and Helpers program in the amount of \$2,000
- b. The FY 2013-14 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area – PL

Bureau Program Expenses - \$2,000

- c. The Office of Management and Finance Grants Management Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

- d. The Chief of the Police Bureau of the City is authorized to accept on behalf of the City any subsequent modifications by Target, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by the City Council.

Section 2. The Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


