ORDINANCE NO. 186442

*Authorize application to the Oregon State Historic Preservation Office for a Historic Preservation Fund Grant in the amount of \$12,000 to support the City's historic resources program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon State Historic Preservation Office (SHPO) invited the City of Portland as a Certified Local Government to apply for a Historic Preservation Fund Grant.
- 2. The Historic Preservation section of the Bureau of Planning and Sustainability is requesting the Historic Resources Fund Grant. The grant will fund preservation planning projects including the preparation of a National Register of Historic Places Multiple Property Documentation form documenting historic resources associated with Portland's African-American community. Funds requested for this grant total \$12,000 for the period April 1, 2014 August 31, 2015..
- 3. Local match in the amount of \$12,000 will be provided by funds from the Historic Preservation and Planning programs (PNSD000002 and PNCP000001) for FY 2013-14 and FY 2014-15. The match will be in the form of salary, benefits, and materials and services in the FY 2013-14 and FY 2014-15 budgets of the Bureau of Planning and Sustainability.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to apply to SHPO for a grant with an application in the amount of \$12,000, in a form substantially in accordance with the form attached as Exhibit A, SHPO Certified Local Government (CLG) Grant Application
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists so that the City can meet the timelines in the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


