

ORDINANCE No. 186453

*Accept a grant in the amount of \$1,000,000 from the Portland Development Commission and authorize an Intergovernmental Agreement for construction of the SE 122nd: Holgate to Ramona Sidewalk Infill Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Bureau of Transportation has partnered with the Portland Development Commission (PDC) to complete construction of the SE 122nd: Holgate to Ramona sidewalk infill project and is accepting a grant in the amount of \$1,000,000 for construction of the project.
2. In April 2011, the Portland Bureau of Transportation (PBOT) received a grant from the Oregon Department of Transportation (ODOT) in the amount of \$870,000 for procurement of Right of Way (ROW) for the project. In addition, PDC partnered with PBOT to fund a portion of the design of the project.
3. Project design is completed, the ROW phase is completed and now PBOT is proceeding with bidding the project for construction.
4. On January 9, 2014, the PDC Commission approved funding to award a grant for the SE 122nd: Holgate to Ramona Sidewalk infill project to PBOT in the amount of \$1,000,000.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-In-Charge is hereby authorized to accept on behalf of the City of Portland a grant from the PDC for the SE 122nd: Holgate to Ramona Sidewalk infill project in the amount of \$1,000,000 and to execute an Intergovernmental Agreement in a form similar to the contract attached as Exhibit A.
- b. The Commissioner-In-Charge is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Commissioner-in-Charge's behalf. The grant ID is TR000192.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


