

## ORDINANCE No. 186456

\*Authorize a contract with the lowest responsible bidder for the SE 122<sup>nd</sup>: SE Ramona to SE Holgate project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The SE 122<sup>nd</sup>: SE Ramona to SE Holgate project will improve pedestrian connectivity, access to transit, safety, accessibility, and leverage these transportation investments to stimulate economic development and private investments in the corridor by installing standard separated sidewalks on the street in this corridor.
2. The Portland Bureau of Transportation (PBOT) applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$870,000 for Right Of Way acquisition and receive the grant and began work in May 2011.
3. The Portland Bureau of Transportation has also partnered with the Portland Development Commission (PDC) on the design and funding to complete construction of the SE 122<sup>nd</sup>: Holgate to Ramona sidewalk project in the amount of \$1,000,000 for construction of the project.
4. On January 9, 2014, the PDC Commission approved funding to award a grant for the SE 122<sup>nd</sup>: Holgate to Ramona Sidewalk infill project to PBOT.
5. Project design is completed, the ROW phase is completed and now PBOT is proceeding with bidding the project for construction.
6. The Bureau's level of confidence in the cost estimates for this project is moderate, as plans, specifications, and estimates are now completed and the project is now ready for bidding.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00206 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the project is seeking to advertise for bids as soon as practicable; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


