

RESOLUTION No. 37057 As Amended

Appoint Bridget Donegan, David Green, Mae Wilson, Jean Tuller, and James Young to the Citizen Review Committee advisory board to the Independent Police Review, a division of the City Auditor's Office (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review (IPR) division and the Citizen Review Committee (CRC);

WHEREAS, a Eleven-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review;

WHEREAS, the committee has five vacancies resulting from the resignation of two members, one term expiration, and two new member positions created by Ordinance 186416, passed by Council on January 8, 2014;

WHEREAS, from 53 applicants, five applicants were recommended by a Selection Committee consisting of three CRC representatives, one member of the community, and the Assistant Program Manager of the Independent Police Review;

WHEREAS, the City Auditor nominated the five recommended members to City Council

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new members Bridget Donegan, David Green, Mae Wilson, Jean Tuller, and James Young for three-year terms that begin February 19, 2014 and end February 19, 2017.

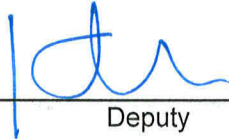
