

ORDINANCE No.

186466

*Pay claim of Glenn Farrell in the sum of \$9,250 involving the Bureau of Environmental Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Glenn Farrell has filed a property damage claim/small claims suit against the City for damages allegedly suffered in the course of sewer repair work involving the the Bureau of Environmental Services in June 2011.
2. The claim has been investigated by Risk Management Services and the City Attorney's office. The investigation indicates there is risk the City may be found liable. Therefore, in accordance with a tentative settlement reached with Mr. Farrell, it is prudent and fair to settle the claim and suit at this time.
3. Risk Management Services recommends the claim/small claims suit be compromised for the total sum of \$9,250, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$9,250 made payable to Glenn Farrell.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim/small claims suit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
