

ORDINANCE No. 186468

*Authorize a contract with Hank Childs Golf Shop, Inc. for concession services at Rose City Golf Course (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:


1. The Director of Parks and Recreation has called for proposals for concession services with the process specified in City Code section 5.32.070 (b).
2. A selection advisory committee appointed by the Director of Portland Parks & Recreation has determined the proposal submitted by Hank Childs Golf Shop, Inc. to be the most advantageous to the City.
3. Having reviewed the proposals and the recommendation of the selection advisory Committee, the Director of Portland Parks & Recreation has agreed and, in turn, Recommends the same to the Commissioner in Charge.

NOW, THEREFORE, The Council Directs:

- a. The Commissioner in Charge is hereby authorized to execute a contract, as per the attached, with Hank Childs Golf Shop, Inc. for concession services at Rose City Golf Course.
- b. The Mayor and Auditor are authorized to draw and deliver warrants chargeable to the Portland Parks & Recreation budget when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the provision of golf services for the users of Rose City Golf Course and excessive cost to the city's Golf Fund; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
