* Amend contract with Environmental Hazard Services, LLC for an additional amount of \$18,000 and extend contract through June 30, 2014 (Ordinance; amend Contract No. 30002316)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On July 1, 2011 a contract was entered into between the City of Portland (City), Portland Housing Bureau (PHB) and Environmental Hazard Services, LLC (EHS) to provide lead paint sample laboratory analysis services.
- 2. The original contract amount was \$18,000 with an expiration date of June 30, 2013.
- 3. The contract was amended to an amount of \$36,000 with an expiration date of June 30, 2013. A second amendment extended the contract to December 31, 2013 with no additional funding
- 4. PHB recommends that Contract No. 30002316 with EHS be amended to increase the compensation by \$18,000 and extend the expiration date to June 30, 2014 for additional services.
- 5. The additional compensation of \$18,000, for a total contract amount not to exceed \$54,000 is to be awarded. Funding is available in FY13-14 PHB budget. The funding is provided as part of the Office of Healthy Homes and Lead Hazard Control Grant received by the City of Portland.

NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is authorized to amend Contract No. 30002316 with EHS for services in accordance with Amendment No. 1 attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Environmental Hazard Services, LLC chargeable to the Portland Housing Bureau when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because of the need for uninterrupted services for the analysis of lead hazards. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
