Subject: Proposed Appointment and Reappointment to the Historic Landmarks Commission

The Historic Landmarks Commission has several upcoming changes that need action.

Appointment

Caroline Dao is President of the Boise Neighborhood Association, and a member of the Land Use and Transportation Committee. She is actively engaged in historic preservation matters, particularly in her neighborhood, which has seen an uptick in development pressure on existing homes in this well-established neighborhood. Most recently she was involved in the highly publicized historic Edwin Rayworth House move in North Portland last fall. Caroline's leadership was an important element, along with many others, to successfully relocate the home to another site several blocks away. Her advocacy during this process was admirable, and her interest to continue this important work with the Historic Landmarks Commission should be immediately felt. For these reasons, **I am recommending that Caroline Dao be appointed** to one of the two Public-at-Large positions on the Historic Landmarks Commission. Caroline's 1st full term will be from March 5, 2014 through March 4. 2018.

<u>Reappointment</u>

Carin Carlson has completed her first term on the Historic Landmarks Commission. Retaining Carin, who has a strong background in Historic Preservation and Restoration, will maintain an invaluable resource for many new restoration projects we are seeing across Irvington and Ladd's Additional particularly. She is currently on leave from the Commission to enjoy time with her new baby, but expressed a strong desire to return to the Commission for a second term, and would start up again in February, if approved. Her reappointment would maintain our high bar, as well as give another four years to Commissioner Carlson to further improve our historic preservation efforts and results in the City. I am recommending Carin Carlson be reappointed to continue in the Public-at-Large position she currently fills for a second full term from December 1, 2013 through November 30, 2017.

With this proposed appointment and reappointment, the Historic Landmarks Commission has no vacancies. I have enclosed an updated Historic Landmarks Commission membership list for your records.

Historic Landmarks Commission:

The Historical Landmarks Commission provides leadership and expertise on maintaining and enhancing Portland's historic and architectural heritage. The Commission identifies and protects buildings and other properties that have historic or cultural significance or special architectural merit. The Commission provides advice on historic preservation matters, and coordinates historic preservation programs in the City. The Commission is also actively involved in the development of design guidelines for historic design districts.

The Historic Landmarks Commission consists of seven members, none of whom may hold public elective office. The Commission must include a historian with knowledge of local history; an architectural historian; an architect; two members from the following: landscape architecture, real estate, construction, community development, urban planning, archeology, law, finance, cultural geography, cultural anthropology, or related disciplines; and two members at-large. All members must have demonstrated interest, competence, or knowledge of historic preservation. No more than two members of the Commission may be in the business of buying, selling, leasing, or developing real estate for profit, or be officers of such a business. The members are appointed by the Mayor and confirmed by the City Council. The terms shall be a maximum of four years with a maximum of two full terms.

Powers and duties. The Historic Landmarks Commission has all of the powers and duties which are assigned to it by PCC Title 33 or by City Council. The Commission powers and duties include:

1. Establishing or removing Historic Landmark and Conservation Landmark designations for specific buildings or sites in quasi-judicial reviews;

2. Recommending the establishment or removal of Historic Landmark and Conservation Landmark designations to the City Council in legislative actions;

3. Recommending the establishment, amendment, or removal of Historic Districts and Conservation Districts to the Planning Commission and the City Council;

4. Recommending and developing design guidelines for Historic Districts and Conservation Districts to the City Council;

5. Reviewing development proposals for Historic Landmarks and Conservation Landmarks and in Historic Districts and Conservation Districts;

6. Reviewing demolition and relocation requests for certain Historic landmarks and buildings in Historic Districts;

7. Providing advice on historic preservation matters to the Hearings Officer, Design Commission, Planning Commission, Portland Development Commission, other City commissions and committees, and City Council; and

8. Initiating and coordinating historic preservation and public outreach programs in the City, including reviewing recommendations for national register status and making recommendations to other governmental agencies regarding historic preservation programs and issues.

The Historic Landmarks Commission meets on the second & fourth Monday of each month at 1:30 p.m.
