

ORDINANCE No. 186497

Amend contract with BergerABAM Inc. for additional work and compensation for the Tryon Creek Sewer Upgrade Project No. E10251 in the amount of \$267,267. (Ordinance; amend Contract No. 30003097)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) entered into Contract No. 30003097 with BergerABAM Inc. on October 29, 2012, to provide professional engineering services for the Tryon Creek Sewer Upgrade Project No. E10251 (ordinance no. 185713.)
2. BES has need of additional professional engineering services from BergerABAM to complete construction documents and permitting, and provide engineering and inspection services during construction of the Tryon Creek Trunk Sewer Upgrades.
3. The estimated cost of this contract amendment is \$267,267. Level of confidence is high. Funds are available in the Sewer System Operating Fund Budget Project No. E10251.
4. M/W/ESB participation after the authorization of this contract amendment will be \$162,506, 21.8% of the amended contract amount of \$744,329.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute Amendment 2 to Contract No. 30003097 with BergerABAM Inc., for the purpose described in Section 1, in the amount of \$267,267.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


