ORDINANCE NO. 186499

* Amend Intergovernmental Agreement with Multnomah County for an additional \$65,000 to be received as revenue for Homeless Outreach Services Staffing Lead (Ordinance; amend Contract No. 30002899)

The City of Portland ordains:

SECTION 1. The Council finds:

- 1. Ordinances No. 185864 and 186369 authorized prior amendments to an authorized Intergovernmental Agreement (IGA) No. 30002899 between the Multnomah County Department of County Human Services (County) and the City of Portland, Portland Housing Bureau (City) to provide a total of \$225,084 in County general funds for flexible outreach and housing placement to veterans and people experiencing homelessness in incorporated and unincorporated areas of Multnomah County east of the Portland city limits (East County).
- 2. The County has initiated an additional amendment (Exhibit A) to the existing IGA to add \$65,000 in County general funds and to extend the scope of the IGA to include an additional Homeless Outreach Services staffing lead.
- 3. The above stated services meet the goals and objectives of the City.
- 4. The City intends to subcontract all work and funds associated with the IGA by amending existing FY 2013-14 City Contract No. 32000967 between the City and JOIN for a total not to exceed \$1,288,000. The County has authorized the City to do so.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are authorized to execute Amendment No. 3 to the Intergovernmental Agreement between the City and the County, attached as Exhibit A.
- b. The Mayor is hereby authorized to accept on behalf of the City payments of up to \$290,084 from the County as specified in the amended IGA.
- c. The Portland Housing Bureau is authorized to perform all administrative matters in relation to the IGA, requests for reimbursement from the County, and to submit required reporting on the Mayor's behalf.

SECTION 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the IGA; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
