This ordinance does not require Council discussion or a presentation because it seeks permission to amend an existing grant to allow for spending down of reprogrammed funds. Council passed a similar ordinance to allow Director to execute IGA's and amendments for regional UASI partners for efficiency and expediency.

History: The Department of Homeland Security through the State Office of Emergency Management has granted an extension through July 31, 2014 for the purpose of spending down grant funds. OEM returned \$100,000 for administrative costs that will be used to extend regional staff through June. All other UASI 11 funds are obligated and will be spent this fiscal year. We cannot finish spending without the extension to our regional partners.
