

ORDINANCE NO. 186533

* Authorize an Intergovernmental Agreement with Multnomah County to provide the Multnomah County Department of Human Services \$100,000 to support and sustain the SUN Community School at David Douglas High School (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland recognizes that the city's future economic and social well-being are dependent on ensuring a strong educational foundation for all city's youth; and
2. David Douglas High School has one of the highest poverty student population rates in the region and is the largest high school in the state; and
3. SUN Community Schools is the central element in the County's SUN Service System of youth and family development; and
4. The FY 2013-14 budget includes funding in the General Fund Special Appropriations for the above IGA. The City now desires to sign an intergovernmental agreement to Multnomah County for an amount not to exceed \$100,000.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into an Intergovernmental Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$100,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2013-14 Budget.


Section 2. The Council declares that an emergency exists because a delay in proceeding could delay or halt the continuation of the services provided by the SUN Community School program; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


