# 1) Legislation Title:

\* Authorize grant agreement of \$25,650 for East Portland Neighbors to administer the newsletter production of East Portland Neighborhood Association News. (Ordinance)

# 2) Purpose of the Proposed Legislation:

The City of Portland, Office of Neighborhood Involvement (ONI) funds the East Portland Neighborhood Office (EPNO), a city-administered neighborhood office, to support communications between the thirteen East Portland neighborhood associations and their community members. EPNO has chosen to produce a district-wide newspaper published by East Portland Neighbors (EPN). EPNO and EPN have mutually agreed to a set of policies to govern the publication of the district-wide newspaper.

Funding was adopted by the City Council as part of the FY 2013-14 ONI budget and is funded with a total of \$25,650 through City General Fund dollars. City Council adopted the Five Year Plan for Increasing Community Involvement on February 27, 2008. In that plan Recommendation Three called for promoting effective communication to keep the community informed about issues and opportunities for involvement by facilitating communication through print newsletters and other means. A total of \$5,000 was supported by the East Portland neighborhood association leadership to continue publication of the East Portland Neighborhood Association News. The East Portland Action Plan, adopted by City Council on February 18, 2009, is directed to support advocacy on action items for east Portland. A total of \$20,650 was directed by the East Portland Action Plan at the December 5, 2013, meeting to support an all-address mailing to the East Portland area containing a survey about infrastructure needs.

A grant of \$25,650 is going to East Portland Neighbors (EPN) for production of the East Portland Neighborhood Association News, a coalition-wide print newsletter for the purpose of encouraging and facilitating communication in outer East Portland.

In that plan Recommendation Three called for promoting effective communication to keep the community informed about issues and opportunities for involvement by facilitating communication through print newsletters and other means. This newsletter provides East Portland specific neighborhood and community news and will provide an opportunity for the community to provide feedback on future infrastructure improvements.

The leadership of the thirteen neighborhood associations in the East Portland Neighborhood Office supported funding for the newsletter. There is a committee made up of community volunteers that guide the operation of the newsletter. Most of the content of the newsletter is written by community volunteers. EPNO and EPN have mutually agreed to a set of policies to govern the publication of the district-wide newspaper. The East Portland Action Plan is supporting the expansion of distribution of the newsletter, and continues to actively participate in providing content. This is an ongoing year-round project.

EPNO neighborhood leaders have chosen to produce a district-wide newspaper and for it to be published by EPN..

### BACKGROUND ANALYSIS 7.

The City of Portland, Office of Neighborhood Involvement (ONI) funds the East Portland Neighborhood Office (EPNO), a city-administered neighborhood office, to support communications between each of the thirteen East Portland neighborhood associations and their community members. EPNO has chosen to pool these funds and produce a district-wide newspaper published by East Portland Neighbors (EPN). EPNO and EPN have mutually agreed to a set of policies to govern the publication of the district-wide newspaper.

Funding was adopted by the City Council as part of the FY 2013-14 ONI budget and is funded with a total of \$32,000 through City General Fund dollars. City Council adopted the Five Year Plan for Increasing Community Involvement on February 27, 2008. In that plan Recommendation Three called for promoting effective communication to keep the community informed about issues and opportunities for involvement by facilitating communication through print newsletters and other means.

A \$5,000 grant is going to East Portland Neighbors (EPN) for production of the summer 2014 issue of the East Portland Neighborhood Association News, a coalition-wide print newsletter for the purpose of encouraging and facilitating communication in outer East Portland. An additional \$20,650 from the East Portland Action Plan is going to East Portland Neighbors for the expansion of the May 2014 issue. This expansion will include extra pages to allow information on East Portland infrastructure projects, including a postage-paid survey insert in the newsletter, mailing to all addresses in East Portland (approximately 58,000), and improving website display of the May 2014 and future issues.
